Each year, the Washington Town & Country Fair recognizes an individual in our community to serve as the Grand Marshal of the annual fair parade that takes place on the Sunday before the fair is set to begin.

Following are the rules and nomination form for the “Grand Marshal of the Washington Town & Country Fair Parade.” The Award will be announced in the *Missourian* no later than July 1.

ELIGIBILITY

The Nominee shall be a resident of Franklin/Warren County and be actively involved in organizations or hold a position of employment that oversees the management of groups of people or organizations that work toward the “good of or to better our community”. Nominee should be a positive person that is seen as a role model for all citizens based on their actions in the community and will have volunteered (by either serving on committees or holding a leadership position) for one or more organizations, a person that has risen above and beyond the call of duty and dedicated countless hours of service. There is no age limit for a nominee.

PROCEDURE

A. Nominations are due in the fair/chamber office by April 30.

B. Nominations shall consist of the Official Nomination Form, including the following questions:

- Describe the nominee’s notable activities and accomplishments – personal, professional, volunteer or otherwise
- Describe how the nominee is/has been instrumental in initiating or leading efforts to benefit our community
- What involvement in organizations or leadership roles has the nominee held in their community?
- Why should this nominee serve as Grand Marshal?

C. The person selected to be the Grand Marshal will be notified by the fair board to ensure attendance at the fair parade to be held the Sunday before the Fair.

JUDGING

Judging will be done by the fair parade committee and fair board.

The committee reserves the right to determine additional persons for consideration.

OFFICIAL NOMINATION FORM – GRAND MARSHAL

This award is designed to recognize an individual that is outstanding in the community based on volunteering, leadership, and has the goals of a better community for us to reside in.

The Grand Marshal will be the leader of the Washington Town & Country Fair Parade that will take place on the Sunday before the fair at 4:00 p.m.
